Funding eligibility and application requirements

In order for your child to be considered for a Continuous Glucose Monitoring (CGM) system funding through the Bacon Bash Texas Dexcom Funding Program, please follow these instructions carefully:

- All applicants must be under the age of 18 and diagnosed with Type 1 Diabetes to qualify for funding.
- Applications must be submitted by November 30, 2018 for consideration for funding beginning January 1, 2019.
- Only requests submitted on this form will be considered for funding.
- All applications must be legible and easy to read.
- Applications must be completed in full, and include all required attachments, at the time of submission.
- Funding will be awarded in December 2018, based on financial and medical need and with priority given to applications submitted by the deadline.
- Parents/legal guardians will receive funding notification (approved and declined applications) by e-mail in December 2018.
- Funds will be directly distributed to providers for Continuous Glucose Monitoring systems.

To apply for Continuous Glucose Monitoring system funding, please submit the following:

1. Completed application
2. Photo of your child
3. Signed photo release form, authorizing photos of camper to be used in fundraising efforts
4. Copy of your 1040 form
