Scholarship eligibility and application requirements

In order for your child to be considered for a diabetic camp scholarship through the Bacon Bash Texas Diabetic Camp Scholarship Program, please follow these instructions carefully:

- All applicants must be under the age of 18 and diagnosed with Type 1 Diabetes to qualify for camp scholarships.
- Scholarship applications must be submitted by November 30, 2018 for consideration for the 2019 camp season.
- Applicants must be **pre-enrolled** in a diabetes camp for the 2019 camp season.
- Only requests submitted on this form will be considered for funding.
- All applications must be legible and easy to read.
- Applications must be completed in full, and include all required attachments, at the time of submission.
- Scholarships will be awarded in March 2019, based on need and with priority given to applications submitted by the deadline.
- Parents/legal guardians will receive scholarship notification (approved and declined applications) by e-mail in March 2019.
- Scholarship checks will be made payable to the camp and will be sent to the camper's parent or legal guardian for distribution and delivery.

To apply for a diabetic camp scholarship, please submit the following:

1. Completed application
2. Photo of your child
3. Signed photo release form, authorizing photos of camper to be used in Bacon Bash Texas fundraising efforts
4. Copy of your most recent 1040 form
